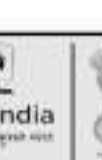
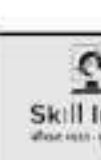

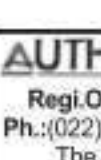

Implementation of Solid Waste management Rules-2026
Mandatory Registration and Responsibility of Bulk Waste Generators.
As per the Solid Waste Management Rules, 2026, any institution or establishment satisfying any one of the following criteria shall be classified as a Bulk Waste Generator (BWG):
• A building having a total built-up area of 20,000 square metres or more; or
• An establishment with a daily water consumption of 40,000 litres or more; or
• An institution or establishment generating 100 kilograms or more of solid waste per day.
As per the above definition, institutional establishments, commercial establishments, residential welfare associations (RWAs), hotels, hospitals, educational institutions, Information Technology (IT) parks, marriage halls, commercial complexes, markets, industries, and other large establishments are all covered under the category of Bulk Waste Generators (BWGs).
• **Mandatory Registration:** All Bulk Waste Generators (BWGs) shall mandatorily register through the official website of Central Pollution Control Board (CPCB) portal.
• **Time Limit for Registration:** All eligible Bulk Waste Generators (BWGs) shall complete the mandatory registration within 15 days from the date of publication of this press release.
• **Action for Non-Compliance:** Appropriate action shall be initiated against Bulk Waste Generators who fail to complete the registration within the stipulated time.
• **Penalty for Violation:** Non-compliance shall invite further enforcement action in accordance with the said Rules.
• Bulk Waste Generators (BWGs) shall procure the required colour-coded bins at their own cost and ensure segregation of waste at source into Wet Waste, Dry Waste, Sanitary Waste and Special Care Waste. The segregated waste shall be placed at the entrance of their premises and handed over to the concerned Thirunindravur Municipality or an agency authorised by it.
• **Extended Bulk Waste Generator Responsibility (EBWGR):** Where a Bulk Waste Generator is unable to process biodegradable (wet) waste within its premises, it shall comply with the provisions relating to Extended Bulk Waste Generator Responsibility (EBWGR) under Rule 10 of the Solid Waste Management Rules, 2026 and obtain the prescribed EBWGR Certificate/Proof of Compliance, wherever applicable, through the concerned Thirunindravur Municipality.
• **Inspection and Verification:** Bulk Waste Generators (BWGs) shall permit inspection of their premises, records and waste management facilities by officers authorised by the concerned Thirunindravur Municipality or any other competent authority under the Solid Waste Management Rules, 2026, and shall furnish such information, records and documents as may be required during inspection or verification

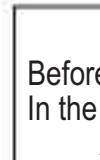

• **Wet Waste:** Kitchen waste, cooked and uncooked food waste, fruit and vegetable waste, flowers, tea leaves, coffee grounds, eggshells and other biodegradable waste.
• **Dry Waste:** Paper, cardboard, newspapers, books, plastic, metal, glass, cartons, textiles, packaging materials and other recyclable waste.
• **Sanitary Waste:** Used sanitary napkins, diapers, incontinence pads, tampons, condoms and other hygiene waste.
• **Special Care Waste (Domestic Hazardous Waste):** Expired medicines, paint containers, pesticide containers, CFL bulbs, tube lights, batteries, mercury-containing items, household e-waste and other domestic hazardous waste notified under the Solid Waste Management Rules, 2026.
